### **Verification Objective and Scope**

The Verification Body conducted the following third-party verification tasks, during the time period of 01/01/2024 to 31/12/2024:

- Evaluation of the management system and the methodology for the quantification, monitoring and reporting of the water footprint of the company, according to the requirements of the standards ISO 14046:2016.
- 2. Onsite verification audits at the following sites:

  - the verification of the existence and application of systems appropriate for monitoring, collection, processing and reporting of data contained in the Water Footprint Report and the documents of the Water Footprint management system of the Company.
  - the assurance of the reliability, the relevance, the completeness, the consistency, the accuracy and the transparency of the quantitative and qualitative data contained in the Water Footprint Report, without any material errors, omissions or misrepresentations.
